Cancellation Fees: All deposits and cancellations fees described herein are per person as follows: If airlines tickets are issued upon receipt of your payment – such tickets are non-refundable, non changeable, non transferable and non endorsable. In addition to cancellation applied by airlines the following administrative cancellation schedule will apply to land services: US\$350.00 will be charged for cancellations received more than 90 days prior to departure; 89 to 61 days prior to departure \$450.00; 60 to 46 days \$750.00; 45 to 31 days prior to departure 50% of the land cost per person will apply; 30 to 22 days prior to departure will be charged 75% of the total land cost per person. Cancellations made 21 days or less prior to departure will be charged 100% per person. There may be special payment and cancellation policies incurred during holiday periods, for certain cruises, and special packages. Programs marked as non-refundable are subject to 100% penalty from time of payment. No refunds will be given for unused portions of tour components or hotel stays, trek tickets, hotels/services over carnival or holiday periods. Changes are treated as cancellations.
